#### Purpose of processing

Purpose: The data collected will be processed to process and manage the request for ATFM departure slot exemption for medical and/or humanitarian flights in accordance with the applicable legislation in force.

Storage periods: The data will be kept for a period of 3 years.

#### Lawful basis

The lawful basis for the processing of data by ENAIRE is Article 6.1(e) of the GDPR: Processing is necessary for the performance of a task carried out for reasons of public interest or in the exercise of official authority vested in the controller:

 Commission Regulation (EU) No 255/2010 of 25 March 2010 laying down common rules on air traffic flow management.

### Recipients

The communicating of data is foreseen, if required and within the framework of fair culture adopted by ENAIRE, to the Spanish State Air Safety Agency (AESA) in the pursuit of its supervisory powers, and to various competent bodies and agencies both within and outside the European Union, in accordance with air safety requirements.

## Rights

Data subjects are entitled to:

- Obtain confirmation on whether Enaire is processing their personal data.
- Access their personal data and seek the rectification of inaccurate data or, where applicable, ask for it to be removed when, among other reasons, it is no longer needed for the purpose for which it was collected.
- Seek, under certain circumstances:
  - A time limit on the processing of their data, in which case it will only be kept by Enaire to exercise claims or defend itself against complaints.
  - Object to the processing of their data, in which case Enaire will no longer process it except for legally binding reasons or to exercise claims or defend itself against complaints. Including the processing of their data for automated individual decisions.
  - The portability of data to be provided to the data subject or transferred to another controller, in a structured, commonly used and machine-readable format.
